## 1. Welcome, logistics, agenda review

Introductions were made, and there were no changes made to the agenda. New members were welcomed to the Committee.

# 2. Minutes from 4/2/19 Meeting

Matt presented draft minutes from the April Steering Committee meeting. There were no edits or corrections suggested, and the draft was **accepted by consensus**.

#### 3. Election of Officers

## 5. <u>Legislative Agenda '20 planning</u>

Matt reviewed the draft schedule for activities to take place during the summer and fall related to the development of the 2020 Legislative Agenda, noting that the schedule might be adjusted after the Equity Subcommittee considers feedback gathered at the Annual Meeting on ways to improve equity, inclusion, and diversity. Steering Committee members **consented to** the outline provided, with the understanding that the Executive Committee may make adjustments as needed

in the coming weeks. Volunteers were then requested for the Agenda Setting Subcommittee, to review the schedule and refine the application process, as needed. Subcommittee members are Margaret, Judy, Jessie, Ann, and Sonja, with Matt staffing.
